Vincent Beckman, posthumously College of Mt. St. Joseph

Vincent believed wholeheartedly in the College's mission as a Catholic liberal arts institution and donated generously to its cause. His bequest provided a substantial six-figure gift that is being used to assist 3 to 4 students annually with their education. Currently over 95% of Mount students receive some sort of scholarship or financial aid, making Vincent's generosity crucial toward their success. In addition to his donation to the College, more than 16 other area nonprofits have benefitted from his foresight.

Carl Bergman Habitat for Humanity of Greater Cincinnati

A board member since 2006, serving as Board President from 2009 to 2011, Carl has always led by example in driving his Habitat colleagues to 'think bigger'. In spite of a weak economy and a 40% decrease in individual donations, Carl pushed for an increase in families served. A retired marketing executive, he built Habitat's ReStore vision of raising money through a store selling new and gently-used building supplies. Carl then spearheaded the launch of three successful ReStores, the merger of the Cincinnati and TriState Habitat affiliates, a substantial increase in the number of homes built, and the launch of a new program to assist veterans. Most recently, Carl and his wife, Julie, made a bequest to establish Habitat's Legacy Builders Giving Circle; and Carl is serving as lead advisor for Habitat's new planned giving program.

Carol Blackschleger American Cancer Society

A volunteer and supporter of the American Cancer Society for over 10 years, Blackschleger's involvement has included serving as a member of its Board of Directors and as vice president of the Warren County Volunteer Leadership Council. Through the Cancer Action Network she has been an avid advocate for legislative issues and patient rights. Additionally she has walked, run and biked hundreds of miles to raise thousands of dollars for the organization's life saving mission and Hope Lodges, which offer free housing for cancer patients and their families.

Patrick Cleary, posthumously Xavier University

An alumnus of Xavier University, class of 1980, Pat was a loyal supporter of his alma mater that greatly enriched his own life. He was particularly proud of being a member of the Father Finn Society, Xavier's legacy society. Having come from a small town, he wanted to provide an opportunity for other students from rural communities to also attend Xavier. Pat's gift established the Patrick J. Cleary Endowment Scholarship. His bequest included all of his taxable estate and his residence.

Tom Cody Cincinnati Children's Hospital Medical Center Currently Chairman of the Board at Children's, Tom is also a respected advocate, long-time donor, and volunteer. His leadership has impacted all aspects of patient care, research, education and advocacy for pediatric health issues. Additionally, he has played a pivotal role in furthering Children's philanthropy. His charitable investments led to the growth of diverse programs, most notably the creation and achievements of The Heart Institute. Tom has also used his talents to recruit other volunteers to advance the global mission the medical center. His bequest was made to support the Cody Mechanical Circulatory Support Initiative to extend cutting-edge treatment for heart failure in children.

Wilbur Cohen
Jewish Federation of Cincinnati

In addition to his Jewish Federation contributions over the past 60 years, Wilbur has been the primary funder of many transformative initiatives including establishing endowments for Cedar Village, Middletown Regional Hospital Women's Risk Assessment Center, Abilities First, Cincinnati Museum Center, Adath Israel Congregation, Temple Beth Shalom Congregation, and many others. He has committed to making a substantial legacy bequest to the Jewish Federation's Endowment Fund which will enable the Federation to support many important programs that bring strength to thousands each year/ Wilbur is a member of the Abraham Moss Legacy Society which honors those who have made a significant planned gift to the Federation and its partner agencies.

Shirley Davies, posthumously Life Enriching Communities Foundation – Twin Lakes

One of the first Twin Lakes residents on its south campus, Shirley's caring demeanor was felt deeply not only at Twin Lakes but also at Christ Hospital where she volunteered for over 30 years. Shirley was both an educator and a lover of music. Her bequest serves as the lead gift for Twin Lakes' Auditorium, which will be named in her honor.

A volunteer of the Ronald McDonald House for over 10 years, Emilie is committed to doing all she can to ensure it can serve as many people as possible. She works at the front desk and often is the one helping families settle into their guest room upon arrival. Emilie's bequest will help generate a growing operating revenue to allow families to focus on their critically ill children for years to come.

Lifelong learning has always been a priority to Bob, whose dedication to the mission of CET spans over three decades. An avid PBS viewer, he has generously given of himself to solicit donations for CET's largest fundraiser, Action Auction. Recently, when CET needed to purchase capital equipment to continue broadcasting to 2.3 million Greater Cincinnatians, Bob made an outright lead gift to ensure the success of a six-figure goal. He also has two significant charitable gift annuities with CET.

United Way of Greater Cincinnati

The Heekins have been deeply involved with the United Way for many years. After helping innovate in community services, volunteer referral and capacity building, she went on to serve on the Board from 1980 to 1989 and the United Way Foundation Board from 1988 to 1997. As a corporate attorney, Trey assisted in fund development on both the annual campaign and the Tocqueville Cabinets. Additionally the couple has been generous donors. Their planned gift began as a bequest; and in 2006, they made their commitment irrevocable, endowing their support through their family's CLH Foundation.

A private banking specialist, Kip followed in his family's footsteps joining the United Way Foundation Board in 2010. He and Jenny realized that through a life insurance gift, they could magnify their impact. Additionally, Kip continues to give his expertise in making planned giving presentations and serving on the committee that oversees policy and strategies for all United Way investments.

Barbara serves as a board member for the Executive Residents Committee and Chair of the Wellness Committee. She has also spearheaded many programs. Jim is a tireless advocate and volunteer of Playhouse, having served in various capacities on its Board for 13 years including as treasurer, and chair of the Finance and Planned Giving Committees. His lead trust has enabled Playhouse to provide accessibility services to patrons with disabilities so that they can full enjoy the theatre's magic.

Recently celebrating her 100<sup>th</sup> birthday, Louise has been a resident of Twin Lakes for over 10 years. Previously she spent decades in leadership roles with the United Methodist Church, bringing inspiration to thousands of followers in every state. Cancer Support Community of Greater Cincinnati & Northern Kentucky

The Young's journey with the Cancer Support Community is a very personal one. Just prior to Tom's election to the Community's board over 10 years ago, he was diagnosed with prostate cancer and treated successfully. It was his own struggle to find information on treatment options that led him to the organization's Cincinnati Prostate Cancer Information Group, which he regularly attends and moderates. The powerful impact of that network led Tom and Susan to join the Community's Lynn Stern (planned giving) Society and contribute a generous bequest to the organization that gave them so much.
